- 9. Noxious Weeds Wes Keller shared common noxious weeds in the neighborhood and the importance of controlling them.
 - 9.1. In conduction with Payette River Sub 2, this past spring we had a spraying day. Chemical was provided by the County.
 - 9.1.1.We are looking to do a similar project next year. We'll need volunteers.

- 9.2.Discussion regarding letter to property owners and/or county regarding lots that are overgrown with noxious weeds.
- 10. Sub Alpine Fir Parasite Wes shared how to spot this parasite on/in trees. (white bubbly bark). Trees can be sprayed to prevent spread of the parasite and potential loss of the tree.
 - 10.1. Wes identified City of McCall Arborist or Department of Lands may help identify if any property owner trees are infested.
- 11. Firewise Mike absent Judy reviewed this past year's project.
 - 11.1. 2017-18 project matching grant of up to \$500 to one property owner who's property had been identified as high-risk. The property owner accepted and cleaned up the lot.
 - 11.2.2018 Ideas we are looking for a leader to run project.
 - 11.2.1. In 2018 a re-evaluation survey is needed. This is done every 5 years. In years past, this has been done from the road. Discussion regarding possible permission by property owner's to enter property for a more accurate survey.
 - 11.2.2. Reminders: firewire a property must have a defensible space, recommendation is up to 50 feet, and property address that illuminates at night.
 - 11.2.3. Goats Discussion regarding hiring to have goats come in again this year. Kathy passed around a sign-up for those interested in more information.
